Terms & Conditions of disposal of condemned vehicles are as under:-

- 1 All the tenders shall have to be submitted quoting the maximum offer price in figure and words along with name & permanent address of the Tenderer in the sealed Tender. The Sealed Tender should be submitted/dropped in the **Tender Box at the office of this Directorate w.e.f. 17/8/2018 to 27/08/2018 at 11.00 hrs. to 16.00 hrs.** dully marked "Tender for purchase of condemned vehicles " on the top of the sealed cover.
- 2 Tenderer may submit their tender on plain paper along with a Demand Draft/Bankers Cheque an amount of 1% of reserve price (each vehicle) in case of APST and 2% for Non- APST (**BANKER'S CHEQUE OF SBI ONLY WILL BE ACCEPTED**) in favour of the "**A.P. State Health Society**" (NHM), as earnest money.
- 3 Sealed tender will be open at State Training Hall of the Mission Directorate office, C- Sector, Naharlagun on 4th Sept' 2018 at 12.30 hrs. in presence of a board of officers, approved by Govt. of AP, Naharlagun. Interested bidder may also be present at the time of opening.
- 4 Earnest money will be retained till deal is finalized. The successful bidder shall have to deposit the full value of his/her offer **within 7(Seven) days** to the office of the undersigned to get the vehicle release order. If within stipulated time the entire amount is not deposited the earnest money will forfeited and the vehicle may be disposed off in any manner at the direction of the undersigned.
- 5 The earnest money of the unsuccessful tenderer will be refunded after completion of the dealt by hand/registered post.
- 6 Intending tenderers may inspect the aforesaid vehicle at any time during office hours except on holiday/Saturday/Sunday in Office premises of the Mission Director (NHM), Arunachal Pradesh, C-Sector, Naharlagun after obtaining permission from the undersigned.
- 7 The quoted amount of the vehicle must not be less than the reserve price.
- 8 If the highest bidder surrenders, his/her earnest money will be forfeited.
- 9 The successful Bidders will have to remove the vehicle **within 3(Three) days** after getting the release order. If failed, the Department will not take any responsibility for loss or damage of the vehicle.
