
a) Entitlements for Pregnant women

- Free and zero expenses Delivery and Caesarean Section
- Free Drugs and Consumables,
- Free essential Diagnostics (blood, urine test, ultrasound etc),
- Free diet during stay in the health facilities (upto 3 days for normal delivery and 7 days for Caesarean Section,
- Free provision of blood,
- Exemption of all kinds of user charges

b) Entitlements for Sick Newborn till 30 days after birth

- Free and zero expenses treatment,
- Free Drugs and Consumables,
- Free Diagnostics,
- Free provision of blood,
- Exemption of all kinds of user charges

This order will come into being with immediate effect.


